- The Mauritian government is committed to adopting a responsible and environmentally sustainable development policy through these four pillars:
 - **(i) Investing in clean energy;**
 - **(ii) Shifting to a cleaner and greener Mauritius;**
 - **(iii) Mitigating risks from climate change; and**
 - **(iv) Protecting our marine resources.**

BUDGET SPEECH 2022-2023

Measures announced in the Budget Speech 2022-2023 to support the green transition

1. Clean-up and embellishment programme
2. Completion of the beach rehabilitation works
3. Implementation of Beach Management Plans
4. Installation of solar lightings at beaches
5. Extension of the Mangroves Plantation and Restoration programme
6. Acquisition of tipper lorries for effective waste collection and disposal
7. Promote locally manufactured products from recycled materials,
8. Improve resource recovery for recyclers

Sustainable Island Mauritius Project

The project aims at promoting sustainable tourism in Mauritius by demonstrating and scaling up a self-sustaining mechanism for improving sustainable added value along the value chain, and improving awareness and marketing of sustainable tourism products.

Sustainable Island Mauritius (SIM)

The main achievements under the Sustainable Island Mauritius project are:

- capacity building of 200 operators on the preservation of the marine eco-system.
- supported the Mauritius Standards Bureau to be accredited by the Global Sustainable Tourism Council as a Certification Body. 60 SME Operators in the Tourism Sector have benefitted from a Certification Scheme under the MS:165 2019 Standards in collaboration with SME Mauritius Ltd.
- The Mauritius Pro-Handprint Innovation Framework (MauPHI) has been developed with Mautourco as a local Destination Management Company and a new product, 'The Wise Dodo' has been developed. Further Tour Operators would be trained on the MauPHI .
- B2B platform to connect artisans and the tourism operators.
- a Creative Guide Book to create successful sustainable products.
- Green Loans/schemes supporting the industry to invest in green technologies.

SOME OTHER SUSTAINABLE TOURISM ACTIONS

The UN Environment, in collaboration with the Ministry of Tourism, launched the “Transforming Tourism Value Chains in Developing Countries and Small Island Developing States (SIDS) to accelerate more resource efficient, low carbon development” project in October 2017.

The objective was to reduce greenhouse emissions and increase resource efficiency within tourism value chains, particularly in the accommodation and food and beverages sector.
