

## Terms and Conditions in joining the Skills in Action Photo Competition 2017

Entrants into the Competition shall be deemed to have accepted these terms and conditions:

- You agree to grant UNESCO-UNEVOC a non-exclusive, irrevocable, royalty-free, worldwide, perpetual licence (with a right to sub-license) to use, republish, edit and/or modify your competition entr(y/ies) in any/all media (including in electronic format, hard copy and in UNESCO-UNEVOC and its affiliate entities' publications and communications for purposes not limited to the competition and as described in these following terms:
  - Wherein, UNESCO-UNEVOC will publish your photo under the Creative Commons BY-NC-SA 3.0 IGO and be stored in photo library including the title and description of your work as well as your name and country of origin
  - Creative Commons BY-NC-SA 3.0 IGO allows the user to reproduce, distribute, adapt and publicly perform UNESCO-UNEVOC Media, with the condition that UNESCO-UNEVOC is credited as being the original source and that the re-distribution of the publication is made under the same conditions as the IGO License. However, the user is required to ask for the express permission of UNESCO-UNEVOC to use the photo for commercial purposes.



- All photos submitted will become property of UNESCO-UNEVOC and will be credited under this format: CC BY-NC-SA 3.0 IGO UNESCO-UNEVOC/Name of photographer
- You give permission to UNESCO-UNEVOC the right to use your name and country of residence for the sole purpose of identifying you as the author of your entry and/or as a winner of the Competition.
- You give permission to UNESCO-UNEVOC (I) to contact you for the purpose of the Skills-in-Action Photo Competition and (II) to share your contact details to its affiliate entities shall there be any interest to independently commission you in the form of, but not limited to, engaging you as a photographer or buying other products of your work.
- You certify that you are the sole proprietor or copyright holder of the photo entry/entries as its author. It should:
  - be your own work, not copied or plagiarized from works of others
  - with a correct and truthful description and is not made up
  - not contain third-party materials or contents you have no permission to use, including brands and trademarks
  - not contain contents deemed as obscene, defamatory, offensive, showing dangerous and inappropriate behaviours and practices, or in breach of any applicable law or regulation, including but not limited to confidentiality obligations you have due to third parties.
  - not contain any identifiable individual whose image is principally featured in the competition entry that has not given consent to the entrant for the use of his/her image in connection with this Competition and in accordance with these Terms and Conditions. Shall a minor, defined in respective applicable laws where the minor picture/s were taken, and is aged less than 18 years old, be featured on the competition entry/entries, the entrant confirms that the parent or guardian of the minor has given relevant legal consent.
- Shall UNESCO-UNEVOC find any reason to believe that your entry/entries breach any of these Terms and Conditions, UNESCO-UNEVOC reserves the right to not consider and disqualify your entry/entries without giving any reasons.
- You are responsible for the cost (if any) of sending your entry to us.
- The Entrant indemnifies UNESCO-UNEVOC International Centre shall an event of fraud, misrepresentation or copyright infringement be made directly by the entrant.
- UNESCO-UNEVOC International Centre reserves the right to modify or cancel the contest or any of the arrangements, schedules, plans or other items directly or indirectly related to the contest, at any time without giving any reason.
- UNESCO's decision will be final. Any attempt by an entrant to influence the result or subvert the contest will lead to immediate disqualification
- UNESCO staff and their family members are not eligible to participate in the photo contest.
